#### Surface preparation:

Surfaces must be clean, dry and prepared in conformity with the general conditions of use pursuant to the technical regulations of use (DTU) and standardization currently in force. Clean the surfaces by the appropriated mechanical or chemical means in order to obtain a dry, sound and clean surface. Remove any micro-organisms and algae with **ONIP MOUSSE** or **FONGIVORE**. For specific or doubtful surfaces, refer to our book of Facade to use the proper primers and their consumption.

**Precautions of use:** Do not apply on moisture, greasy or frozen surfaces.
